

Environmental Monitoring Update: Week of February 1, 2021

Air Monitoring

Below are graphs indicating the results of air monitoring for volatile organics during construction activities for the period February 1, 2021 through February 5, 2021. Average daily concentrations are shown for each of the 14 stations in the network. Station locations are shown in the schematic below. Meteorological data collected in the project staging area are shown in the Table below for the same calendar period as well. The data reflected in the graphs represent readings from 6:00 am – 6:00 pm on working days. There were no concentrations of volatile compounds or dust attributable to construction activities above the threshold during the same calendar period.

Average TVOC Concentration Week 12: 2/1/2021 - 2/5/2021


