

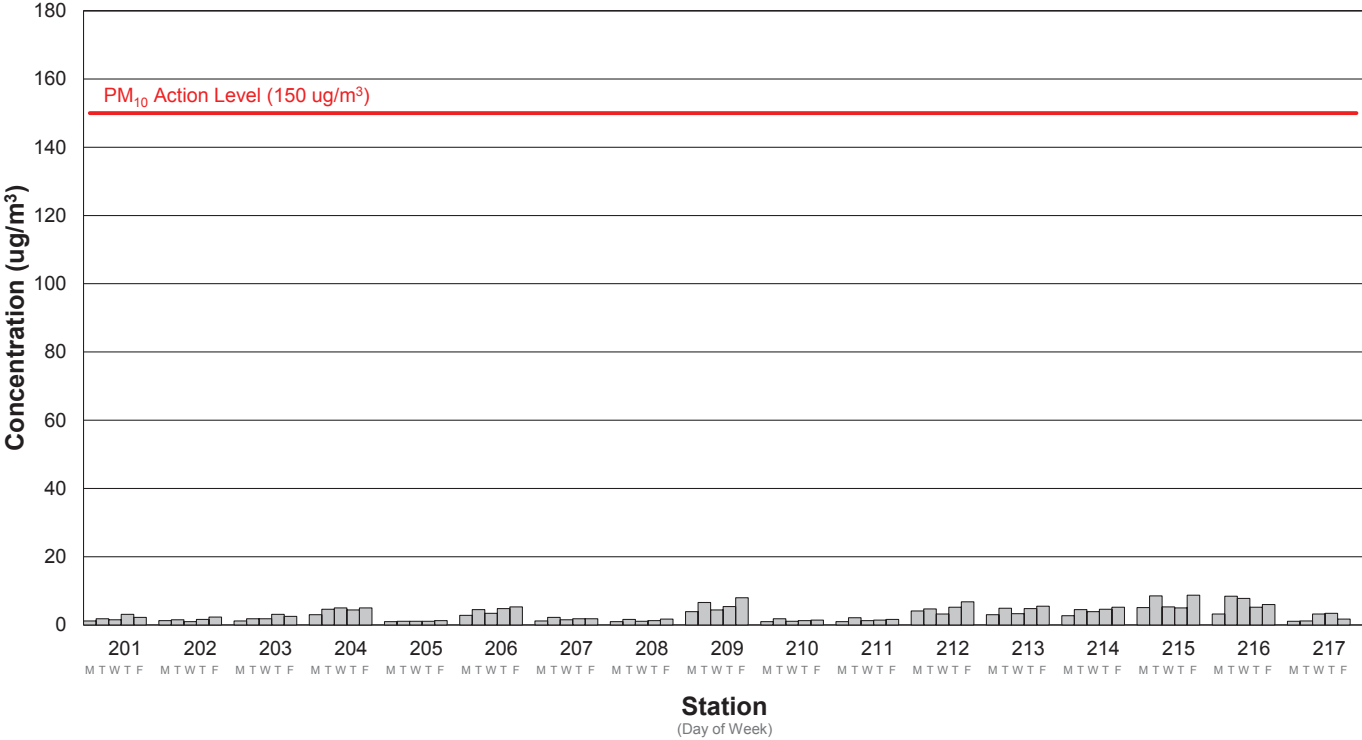

## Environmental Monitoring Update Week of April 7, 2025

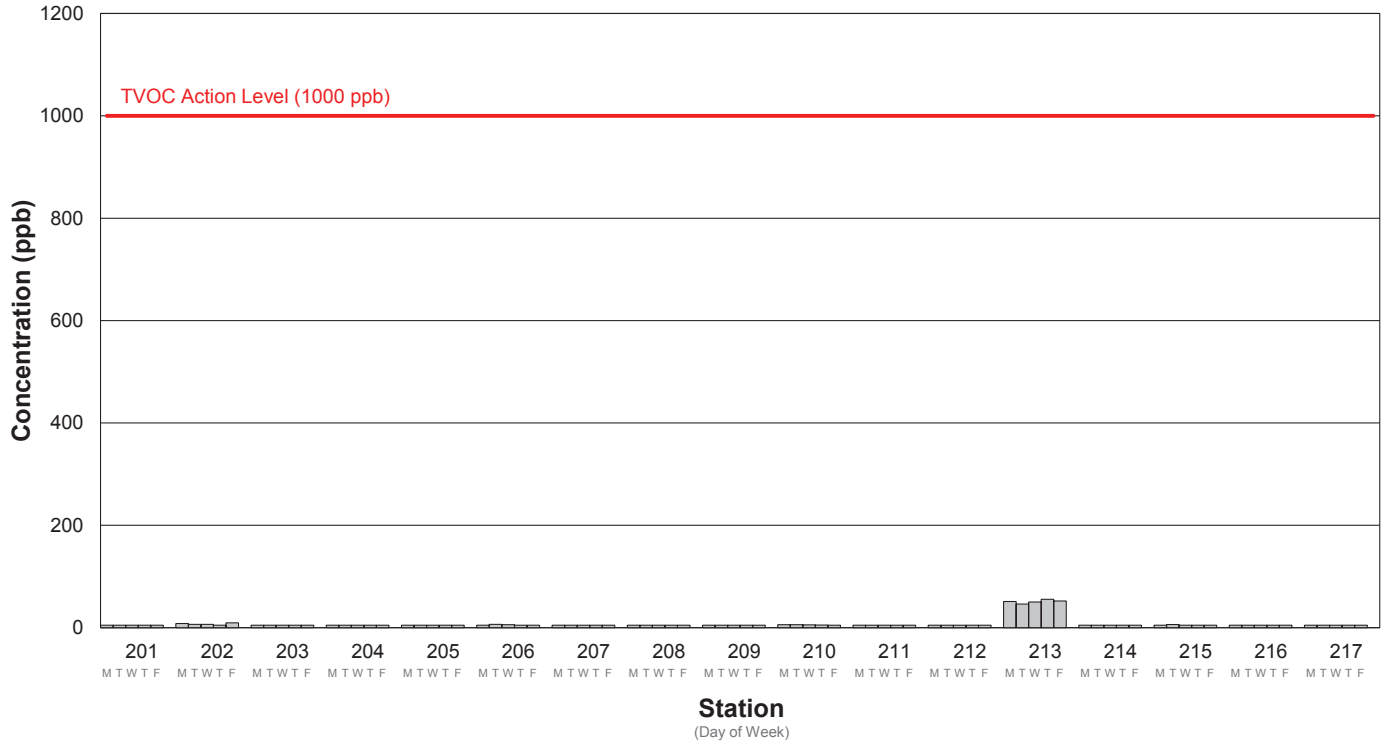
### Air Monitoring

The Gowanus Remediation Team provides the results of air monitoring for particulate matter and volatile organics during construction activities. Typical working hours are weekdays from 6:00 am – 6:00 pm. This report contains data for the period April 7, 2025 through April 11, 2025. Daily averages are shown for each of the monitoring stations in the network. There were no concentrations of volatile compounds or particulate matter attributable to construction activities above the Action Levels during the same calendar period.
