

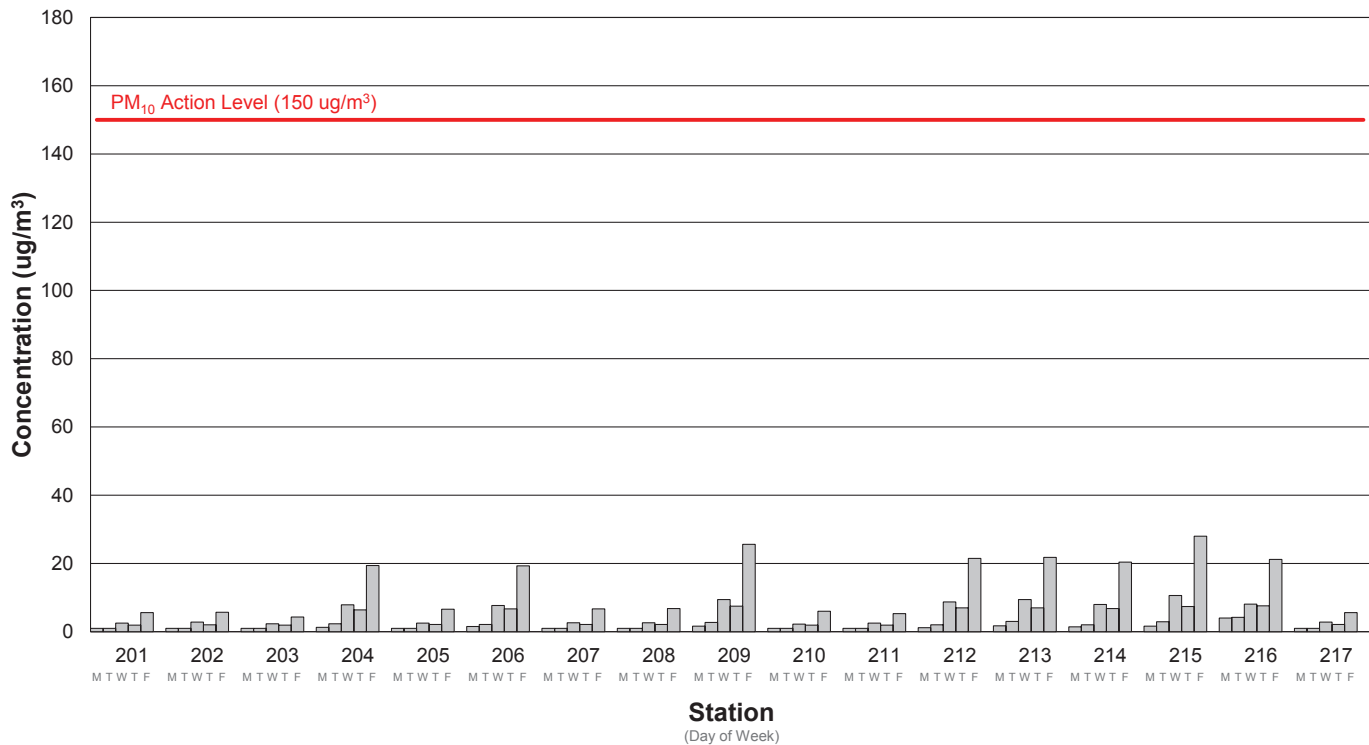

Environmental Monitoring Update Week of November 17, 2025

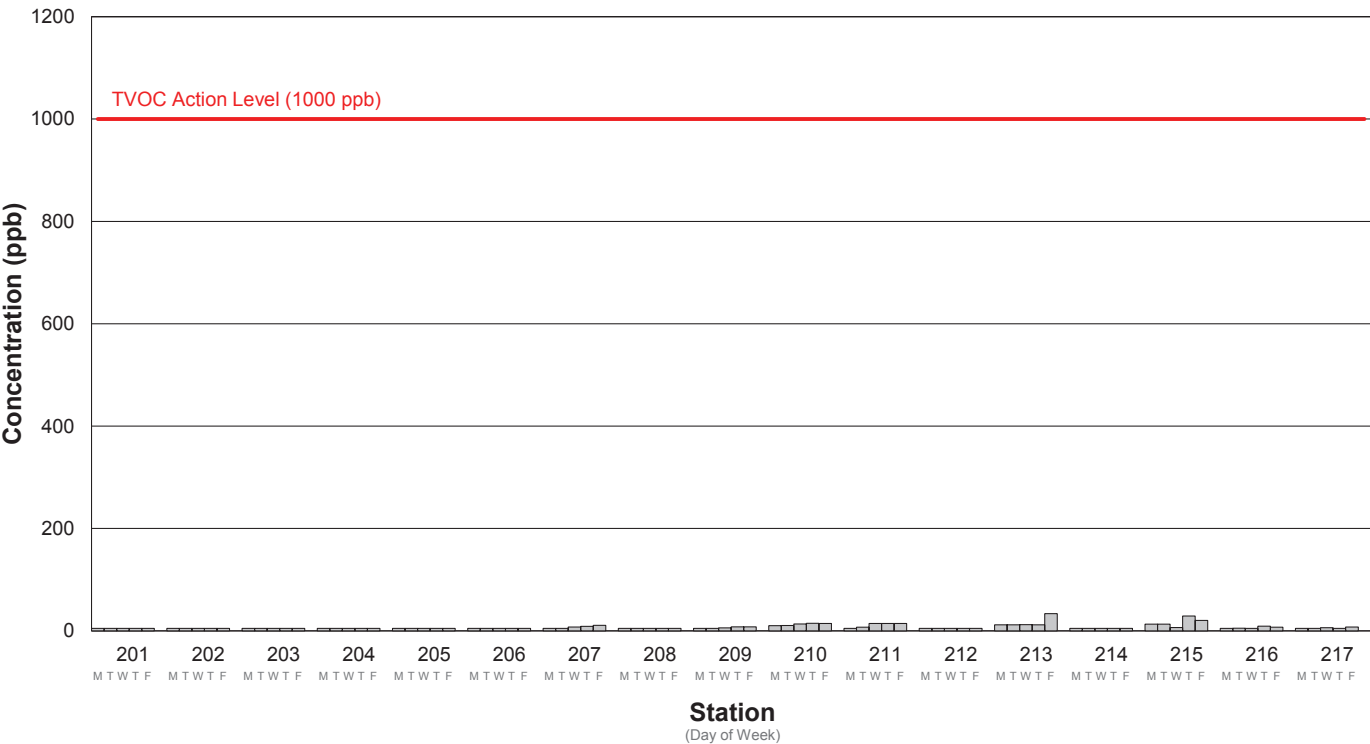
Air Monitoring

The Gowanus Remediation Team provides the results of air monitoring for particulate matter and volatile organics during construction activities. Typical working hours are weekdays from 6:00 am – 6:00 pm. This report contains data for the period November 17, 2025 through November 21, 2025. Daily averages are shown for each of the monitoring stations in the network. There were no concentrations of volatile compounds or particulate matter attributable to construction activities above the Action Levels during the same calendar period.

Noise Monitoring

Noise monitoring data was collected at the Staging Site and adjacent to work activities within the canal. All noise monitoring data collected at these locations was below the 85 dBA allowable equivalent noise level.
